

## CORNELL BRANCH TERMS OF SCHOLARSHIP 2017-18

All recipients of a residential scholarship at a Branch of Telluride Association are expected to maintain the highest standards of conduct and participation in their community and academic life. Each residential scholarship participant will, at a minimum:

- i. The recipient will be registered as a full-time student in good standing at the university, actively pursuing an undergraduate or graduate degree.
- ii. The recipient will obey all applicable laws; adhere to the university's rules, regulations, and code of conduct; and comply with applicable Telluride Association rules and policies.
- iii. The recipient will maintain a semesterly Grade Point Average of "B" (3.0) or better, and will complete at least three-fourths of all credits attempted, in each academic term.
- iv. The recipient will complete, in a timely fashion, the quota of TASS and/or TASP application reading as assigned by Telluride Association and the Branch Applications Officers. The number of application readings assigned will not exceed 80 per year.
- v. Each Branch shall complete annual orientation, including training addressing sexual harassment, conflict resolution, and diversity inclusion. Failure on the part of an individual to complete the required training within the first two months of House residence will initiate a formal scholarship review by the Branch Committee. **Any individual who is unable to attend orientation when it is initially offered must complete make-up activities that constitute a time commitment and content comparable to that of the original activities.**
- vi. The recipient will fulfill a public speaking (PubSpeak) requirement by delivering at least one PubSpeak on a topic of their choosing per academic year, **regardless of when the student joins the Branch.**
- vii. **Within the first two months of each year, the recipient will provide to the Branch Committee a statement explaining the student's reasons for residence at the Branch, a plan that describes what they hope to learn from Branch membership and how they will learn it, and the contributions the student aims to make to the Branch in the coming year.**
- viii. **The recipient will participate in one Regular Assessment of Preference meeting with the Branch Committee for each semester in which the student resides in the Branch.**
- ix. **The recipient will complete an evaluation process each semester, using a system determined by the Branch, and file the evaluation documents with the relevant Branch office.**
- x. The recipient will annually read the present Part (IV) of TARP and sign a document attesting to their understanding of this portion of Telluride Association's Rules and Procedures.

My failure to comply with these standards of conduct and participation, as determined by campus or law enforcement authorities if applicable, may result in disciplinary action up to and including the immediate revocation of my residential scholarship and discontinuation of any cash awards, at the sole discretion of Telluride Association. In addition, the Association reserves the right to immediately terminate my scholarship and residency privileges if I engage in or threaten acts that in the Association's sole opinion, may threaten the safety, health, or well-being of the Branch community or the personal safety or security of any Branchmember (including by acts of harassment).

This statement is a legal agreement between myself and Telluride Association, and is not a lease. It supersedes any prior contracts or understandings regarding my conditions of residence, whether oral or written. Any termination of my housing privileges for the above reasons will be considered a "for cause" termination.

I hereby indicate that I understand and accept the above terms as a condition of my residential scholarship at the Cornell Branch of Telluride Association during the occupancy period of August 18 - Dec. 17, 2016 and January 20 - May 25, 2017.
